

2024-2025 Verification Worksheet

Your 2024-2025 FAFSA was selected for review in a process called **Verification**. Before awarding federal aid, we must ask you to confirm the information reported on your FAFSA. To verify that you provided correct information, you and at least one parent (if you are a dependent student) must complete this worksheet, attach any required documents, and submit all paperwork to Student Financial Services via email at financialservices@montreat.edu or fax at 828-412-0257. Do not leave any section blank or unsigned as this will cause your paperwork to be marked as incomplete and will result in our inability to disburse your federal aid. **We cannot accept pictures of documents; all paperwork should be submitted in .pdf format**. Please note that any adjustments made to your FAFSA as a result of Verification could affect the amount of financial aid you are eligible to receive which could alter your balance due.

IMPORTANT - This form will be considered invalid if:

- It is not signed by both the student and parent (if dependent)
- All household members, including yourself, are not listed
- 1040 forms are not manually signed by the taxpayer or include an EIN from a preparer
