CACREP Self-study

The CACREP self-study is a comprehensive evaluation process undertaken by counseling programs seeking and maintaining accreditation. This self-study involves a detailed assessment of the program's curriculum, faculty qualifications, student outcomes, and adherence to established standards. It serves as both a reflective exercise for program administrators and a crucial step in demonstrating the program's commitment to quality education and continuous improvement. By engaging in this self-study, programs can identify strengths and areas for growth, ultimately enhancing the training and preparation of future counselors.

CACREP Accreditation for Online Program

Montreat College has received full accreditation from the Council for Accreditation of Counseling and Related Educational Programs (CACREP) for its online Clinical Mental Health Counseling (CMHC) program, reinforcing its commitment to high-quality education in mental health counseling. Previously offering a hybrid model, the college transitioned to a fully online format in January 2024, meeting CACREP's rigorous standards. Dr. Mark Hijleh, Provost, emphasized that this accreditation ensures academic excellence and effective training for students. The program prepares graduates for impactful careers by offering a balanced lifestyle, mentorship opportunities, internships with around 700 hours of experience, and personalized guidance from expert faculty, enhancing professional opportunities for licensure and employment.

Program Evaluation and Student Assessment

The CMHC program uses several metrics to assess the achievement of program objectives, including: an annual faculty review meeting, surveys to stakeholders, counselor examination scores (CPCE & NCE), student disposition assessments, grade point average, clinical performance evaluations, attainment of student learning objectives, and an assessment of curricular offerings.

As faculty, we ask ourselves, "Are we teaching our students the skills and theories that need to become Licensed Clinical Mental Health Counselors in North Carolina?" As soon as students enter the program, we begin to evaluate their progress. This is accomplished through students' grades, analysis of end of course rubric (Key Performance Indicators [KPI]), and results of the exit examination (CPCE). Although it is labor intensive, the CPCE/NCE coordinator verifies the provisional licenses of recent CMHC graduates. We assess Student Learning Outcomes (SLOs) that measure essential counseling competencies for entry-level clinical mental health counselors and students' portfolios which are placed in a secure folder in the program's Google drive. CMHC faculty review these program assessment data to determine what is being done well and where there are opportunities for improvement. We identify changes to make with curriculum, staffing, policy, and procedures and establish a timeline for the changes.



Annual Report

An integral part of encapsulating and understanding Montreat College's Clinical Mental Health Counseling (CMHC) program is through the Annual Report. Faculty annually distribute an official report, entitled *Montreat College Annual Report (Annual Report)*, documenting the outcomes of the systematic program evaluation to students currently in the program, program faculty, institutional administrators, and personnel in cooperating agencies (e.g. employers, site supervisors).

The data which informs the *Annual Report* is gathered through *SurveyMonkey* at the end of each academic year. The *Annual Report* includes data from current students, alumni, site supervisors of current CMHC students, and employers of CMHC Program alumni. The gathered data ensures the program faculty better understand successes and areas of growth, as well as appropriately plan for future academic years. The goal of the *Annual Report* is to establish a concise summary of on-going program evaluation efforts and updates.

The Annual Report is then collaboratively written by <u>program faculty</u> and discussed in meetings between Montreat College's CACREP Liaison and the CMHC Program Chair, as well as addressed among program faculty in monthly departmental meetings. The Annual Report for a given academic year is written and distributed prior to a new academic year beginning. The Annual Report is distributed to current students, program faculty, College administration, as well as site supervisors of current CMHC students and employers of alumni. Additionally, a link to pdfs of past and present Annual Reports is provided on the College's Clinical Mental Health Counseling <u>webpage</u>, information which is also made known to each of the aforementioned constituents.

Program Milestones & Changes 2023-2024

Under the leadership of department chair, Megan Clunan, PhD, LCMHCS, NCC the following changes occurred:

• Montreat College, fully accredited by the Council for Accreditation of Counseling and Related Educational Programs (CACREP), is transitioning to a fully online 8-week class format with in-person residencies. This new approach provides greater flexibility for students while upholding the standards of CACREP. The online classes allow students to engage with course materials remotely, while the residency component fosters community and collaboration among peers and faculty. This model enhances the educational experience and equips students with the skills needed to succeed in the counseling profession.



- Montreat College welcomed Dr. Tora N. Kincaid, Ph.D., QS, LCMHC, LCASA, NCC, BC-TMH, a visiting professor and Clinical Director of the CMHC Program at Montreat College and a professor at Lenoir Rhyne University. Dr. Kincaid is a Licensed Clinical Mental Health Counselor, a Qualified Supervisor, a Licensed Clinical Addictions Specialist Associate, and a National Board-Certified Counselor who works with various client populations in private practice. Her platform focuses on raising mental health awareness through education and conversations that break the silence associated with mental illness in Black and Brown communities, stigmatized populations, such as cosplayers, and in the church. Dr. Kincaid has worked in the mental health field for over twenty-six years and is a frequent speaker at professional conferences across the country and is a Subject Matter Expert with the National Board for Certified Counselors.
- Dr. Tyreeka Williams resigned her position from Montreat College as the 2024 Interim Program Director after serving as full time faculty since 2023.
- Dr. Lisa Hedden resigned her position at Montreat College as the 2023-2024 Clinical Director.


The Assessment Process

Surveys to stakeholders. Montreat sought annual feedback from key CMHC program stakeholders, including current students, site supervisors, alumni, and alumni employers to identify strengths and areas for improvement. This feedback was collected through email surveys via SurveyMonkey, with reminders sent to non-respondents a week later. The surveys assessed stakeholders' perceptions of the program's quality in fulfilling its mission and training counselors for professional practice.



Current Student Survey

Every year of study, all enrolled students are invited to complete a current student survey sent via email by SurveyMonkey, assessing their experience of the program. The CACREP liaison/assessment coordinator compiles these results annually and provides them to the Program Director. The Program Director reviews this data with faculty at a future faculty meeting in the fall. 




Current students report their feelings about the program in the following areas:


The program offers the opportunity for students to demonstrate content, knowledge, skills, and understanding.


The program offers opportunities to examine the impact of diversity.



Alumni Survey


Each summer, an Alumni Survey is sent to recent graduates of the CMHC program. Alumni answer questions about their achievement of Student Learning Outcomes and preparedness for Professional Counseling. The survey assesses their perceptions of readiness for credentialing and practice issues. The Counseling Program Director shares the summary results at a faculty meeting, where core faculty review them and document any recommended program changes. Alumni report their preparedness in the following areas:





Site Supervisor Survey

Every year of study, all site supervisors are invited to complete a current student survey sent via email by SurveyMonkey, assessing their experience of the program and the students whom they supervise. The CACREP liaison/assessment coordinator compiles these results annually and provides them to the Program Director. The Program Director reviews this data with faculty at a future faculty meeting in the fall. Employer survey

Annually, in the summer term, an Employer Survey is sent out to employers. The CACREP liaison/assessment coordinator compiles these results annually and provides them to the Program Director. The Program Director reviews this data with faculty at a future faculty meeting in the fall. Upon completion of any one of the following courses the teaching instructor is to complete the fillable KPI rubric associated with the given students', course, and assignment. It is the Program Director's responsibility to email the teaching instructor requesting such at the end of each semester/term. The teaching instructor is to then email the Graduate Assistants all completed evaluations, for saving in the student's CMCH program file. The KPI rubrics are a part of the student's CMHC portfolio.

- Class performance. Montreat requires all graduate students to maintain a cumulative GPA of 3.0. Students who fall under the 3.0 threshold are placed on an academic remediation plan as described in the CMHC Student Handbook.
- Counselor preparation comprehensive examination (CPCE). The primary metric used to
 determine the quality of the program's preparation are the scores achieved by students on the
 Counselor Preparation Comprehensive Examination (CPCE). This exam is required for
 graduation of CMHC students and is usually administered during the opening weeks of their
 practicum experience. Students whose overall CPCE score is below 71, are required to retake
 the examination. Students are required to pass all eight core knowledge domains or be
 subject to remediation.

Students are sent an email invitation via SurveyMonkey. They are given a week to complete a quiz on SurveyMonkey which covers the area(s) which fall below the national cut-off scores. Scores for students are compared to the national average. Montreat's students have consistently been within a standard deviation of mean scores across the nation. Their pass rates, after remediation, are reflected in the following table:

National counselor examination

Another metric used to determine the quality of the program's preparation are the scores achieved by students on the national counselor examination. This exam is not required for graduation of CMHC students; however, it is required for provisional licensure in North Carolina. Scores for students are compared to the national average. Montreat's students have consistently been within a standard deviation of mean scores across the nation. Their pass rates are reflected in the following table:
